MIRA VIZSLAS STUD DOG CONTRACT – Frozen Semen

Following are the terms for use of the stud dog named below. The laws of the state of Wisconsin, USA, shall govern this contract. Any disputes shall be settled in Jackson County, Wisconsin. The bitch's owner shall hereinafter be referred to as "the breeder". The stud dog owner shall hereinafter be referred to as "the sire's owner".

1) This contract applies only to the dog,	hereafter referred to as "the
sire" or "stud", being used at stud on	hereafter referred to as "the
bitch". The sire may not be used on any other bitch owned by the breeder	without a separate contract
naming that bitch and no dog other than the sire may be used on the bitch w	vithout the express consent of
the breeder	

2) The breeder shall provide the sire's owner copies of the OFA certificate which shows the OFA rating of the bitch, a copy of the certified AKC pedigree, a copy of the official AKC Registration papers, and a copy of any other health clearances or links to their location on the OFA website.

The sire's owner shall provide copies of an OFA certificate which shows the OFA rating of the sire and a copy of the sire's certified AKC pedigree.

3) If the breeder elects to have fresh chilled or frozen semen shipped to the Bitch the entire cost is that of the Bitch owner, and payable at the time of collection. This fee is in addition to the stud fee. Litter papers will not be signed until the remainder of the stud fee and the entire cost of the Chilled/Frozen semen expenses are paid in full.

If breeding does not take, the Breeder is still responsible for the cost of the Chilled/Frozen semen expenses. Further, if semen was drawn and arrived in good shape and Bitch owner does not wish to repeat the breeding the original deposit will serve as the fee for the original breeding plus any out of pocket expenses Stud dog owner has acquired, and this contract will be null and void. Should bitch owner choose to do a second breeding - the remainder of the stud fee is due up front.

4) If the Breeder elects to use natural live cover breeding, prior to breeding the Stud dog owner will provide Bitch owner with: A four generation pedigree, OFA certificates, along with any other clearances or testing results that have been performed on Stud dog. Breeder will provide Stud dog owner with same information and paperwork before any breeding is performed. Breeder must provide stud owners with a copy of the Dam's AKC registration paper.

Before breeding naturally, the Breeder will provide Sire owner with a documentation of a clear vaginal culture. This is to protect both the Stud and Bitch. Further, it is suggested that the culture be done far enough in advance to allow treatment of any problems with antibiotics before the breeding.

Breeder is responsible for all testing done to the bitch prior to and during breeding to assure the proper timing of said breeding. If Stud dog is able to perform naturally and for some reason the Bitch owner asks for artificial insemination or the Bitch cannot be bred naturally, Bitch owner is responsible for cost of said process. If bitch owner is not willing to pay for progesterone testing, smears or Al's this should be stated ahead of time and included in the contract initialed by both parties.

5) The breeder agrees that no puppy resulting from the breeding shall under any circumstance be consigned to a raffle, sold through a pet store, a broker, or other third party. The breeder shall furnish the sire's owner a list of the names of those persons who buy a puppy resulting from this breeding. The breeder will be responsible for the placing of puppies into responsible homes, and will accept lifetime return of any dog resulting from the mating of the two above named dogs for the life of the dog. If a puppy from the above mating should ever end up in breed rescue, the breeder is required to accept the dog and find it another responsible home. The sire's owner agrees to accept return of any puppy if the breeder is unable to do so. If the sire's owner accepts return of a puppy, the breeder shall be responsible for any financial reimbursement due the puppy buyer and agrees to pay the sire's owner for care and placement of the puppy, including daily board at the current local rate.

5) The stud fee is \$2000, with 50% deposit being due prior to breeding or shipping semen, and the final half due prior to Stud owner signing/approving AKC litter registration application. In the event of two or less puppies at the time of tail docking, the deposit shall serve as the stud fee. Any repeat stud service shall be under separate contract.

Any other agreements or terms shall be negotiated by separate contract.

By signing this contract, the breeder agrees that he/she has authorization from any co-owners of the above named bitch to proceed with this breeding and to relieve the sire's owners from any liability they may incur as a result of the use of the sire for this breeding.
